### SHUTTLE:

Complimentary town shuttle around Crested Butte and Mt. Crested Butte (ski area) — stops ½ block from the Inn. The town shuttle runs at least every 15 minutes and travels 2½ miles to Mt. Crested Butte, stopping at the ski area, returning to the Old Town Inn via a swing around the downtown area.

**\*COST: \$505/person** for coach transportation and 4 nights' lodging (double occupancy). There is an \$8 per day charge for each additional person in a room beyond two.

**\*SKI LIFT COST:** Recommend that each individual, if they do not have the EPIC Season Pass, to purchase their EPIC Day pass directly from Crested Butte online at <https://www.skicb.com/plan-your-trip/lift-access/passes/epic-day-pass.aspx>. You will get a discount if ordered at least 9 days in advance. The price is the same that is offered for group tickets.

**Deposit (to lock-in your reservation): \$250 per person is due ASAP**

**Final Coach/Lodging Payment: \$255 per person is due NLT December 15, 2021**
