## Celebrating Military Milestones and Anniversaries in 2021

Let's dispense with the first anniversary. The COVID-19 pandemic virus and lock downs, closures, quarantines, and sequestering that is one year old. This is not much to celebrate. Begrudgingly, we will persist, although it is hard to find a patriotic ribbon to tie around it.

Second. 2021 marks the 100th anniversary of the Tomb of the Unknown Soldier at Arlington National Cemetery. The centennial commemoration, directed by the 2017 National Defense Authorization Act, will feature a series of events leading up to a ceremony at the tomb on Nov. 11. On Nov. 11, Veterans Day, there will be a full honors procession and a wreath-laying ceremony. Members of the public will be able to experience and participate in events at the cemetery and virtually.

Congress approved the burial of an unidentified American soldier from World War I in the plaza of Arlington National Cemetery on March 4, 1921. The tomb, which stands atop a hill overlooking Washington D.C., has since come to symbolize the sacrifices of all U.S. service members. *"It is hoped that the grave of this unidentified warrior will become a shrine of patriotism for all the ages to come, which will be a source of inspiration, reverence and love of country for future generations"* - Congressman Hamilton Fish III (NY), March 9, 1921.

Its white marble sarcophagus, which stands above the grave of the Unknown Soldier of World War I, depicts three carved Greek figures representing peace, victory and valor. Inscribed on the back of the tomb are the words: *"Here rests in honored glory an American soldier known but to God."*

To the west of the sarcophagus are the crypts for an Unknown Soldier from World War II and the Korean War. A crypt designated for the Vietnam Unknown was dedicated on Sept. 17, 1999.

In 1926, Congress established a military guard to protect the tomb, and since July 2, 1937, the Army has maintained a 24-hour guard over the tomb. Sentinels from the 3rd U.S. Infantry Regiment (The Old Guard) assumed those duties on April 6, 1948, and they have maintained a constant vigil ever since.

Third. On Its 80th Anniversary, the USO Looks Back on Eight Decades of Standing by the U.S. Military.

Starting in 1941 and in the eight decades since, the USO has remained committed to always standing by the military's side, no matter where their service takes them.

### The USO During World War II

A few months before the United States' official entry into World War II, President Franklin D. Roosevelt was already creating a support system for the nation's Armed Forces. Bringing together the Salvation Army, the Young Men's Christian Association (YMCA), the Young Women's Christian Association (YWCA), the National Catholic Community Service, the National Travelers Aid Association and the National Jewish Welfare Board, these six organizations formed the United Service Organizations (USO) on February 4, 1941. The USO was created specifically to provide morale and recreation services to the troops. USO created a network of centers and lounges across the United States for their recreational use. Churches, stores, museums and even locations such as barns and railroad cars were quickly transformed into welcoming spaces for service members.

For the wives following their soldier from camp to camp within the U.S., the USO created programs and services for them as well. The USO provided them with resources for financial budgeting, childcare, education and social events to meet other spouses.

On the front lines in the Europe and Pacific Theatres, the mission of delivering a piece of home to military members was even more crucial. To alleviate the strain of being far from home and loved ones, as well as ease the intensity of fighting a war, the USO stepped up to help.

It was during World War II that the USO created and established its legacy of entertainment through USO Camp Shows. Roughly one month after Allied troops landed on the beaches of Normandy on D-Day, 26 USO entertainers arrived on Utah Beach to perform for the troops.

From there, a number of USO Camp Shows troupes traveled across Europe. These USO Camp Shows traveled through North Africa, the Middle East and the Pacific, where morale boosts were especially needed. In 1947, two years after the end of World War II, the organization was “honorably discharged” by President Truman,

In 1950, the Korean War broke out; just five years after that, the Vietnam War began. Just one year before the Korean War, in 1949, President Truman reactivated the USO and in the following years the doors opened to the first USO centers in combat zones.

At the peak of the Viet Nam war, the USO had 17 centers in Vietnam and 6 in Thailand. And after 1964, holidays on the front lines would never be the same. This was the year Bob Hope brought his first-ever Bob Hope USO Christmas Show to Vietnam ready to entertain service members just when they needed it most. The show became a yearly tradition and it continued until 1990.

As the world moved into the end of the 20th century and the beginning of the 21st, the United States engaged in a series of conflicts and peacekeeping missions. Most notable of these, which the USO provided support for, were the Gulf War, Operation Joint Endeavour and Operation Restore Hope.

At home, USO airports throughout the country became known not only as a lounge for service members, but a place for all members of the military community to rely upon when struggling with travel delays, flight cancellations or simply needing a refuge after long hours of traveling. At home or abroad, when service members or military spouses saw that familiar red, white and blue logo, they knew they could finally relax.

September 11, 2001, changed everything. The United States entered the Global War on Terror and the military community was suddenly faced with new challenges and missions overseas. Since 2001, more than 2.77 million service members have deployed to Iraq and Afghanistan on 5.4 million deployments.

Aside from the strain of deployment on the service member, military spouses and children must also weather the storm of military life and all its uncertainties. Because of this, over the past 20 years the USO has particularly focused its efforts on supporting not only service members, but their spouses and children as well, throughout their entire military journey.

As the USO enters its 80th year, over eight decades, no matter the conflict or period of peace, the USO has always stood by the military service members' side. The USO's programs and support have always centered around its mission to strengthen America's service members by keeping them connected to family, home and country, throughout their service to the nation.

Remember and respectfully salute, both, the volunteers and services provided by the USO that were – and continue to be – funded and staffed by charitable donations and those volunteers.

### **New Mexico 2021 Legislative Session**

As of the writing for this edition of “Mail Call”, the New Mexico Legislative Session is nearing the midpoint. This will be a session to be remembered and my humble opinion, not fondly. The Capitol is closed to the public, thus preventing the citizens of New Mexico to observe committee and floor hearings. More importantly, it is difficult to voice your concerns to the legislature that impacts military members, veterans, military retirees and surviving spouses. There is a way to be heard in committee meetings, which I will describe at the end of the newsletter.

The list of legislation for 2021 that affects military members, veterans, retirees and surviving spouses is fairly extensive.

**House Joint Resolution 2** sponsored by Rep. Alcon, District 6, proposes to allow veterans to claim an exemption to their property tax equal to the percentage of their disability rating. Currently, only a veteran who is 100% disabled can claim a 100% exemption. This exemption applies to the veteran’s widow or widower. The resolution has been recommended by two committees to “Do Pass” and is scheduled to be debated on the House Floor.

**House Joint Resolution 3** sponsored by Rep. Alcon proposes to increase the property tax exemption of honorably discharged veterans from \$4,000 to \$10,000 beginning in 2023. The resolution has been recommended by two committee to “do Pass and is scheduled to be debated on the House Floor.

**Senate Bill 259** sponsored by Sen Burt, District 33, proposes a deduction from net income of military retirement income in four graduated phase beginning in tax year 2022 and culminating in tax year 2025 with a 100% deduction not to exceed \$25,000.

**Senate Bill 277** sponsored by Sen. Polk, District 23, proposes a \$30,000 exemption to military retirement pay beginning in tax year 2021. Sen. Pope is a retired Air Force officer

**Income Tax Exemption Discussion** The two bills introduced in this legislative session are similar to bills introduced over the last 10 years. New Mexico is one of five states that fully tax military retirement pay. The Fiscal Impact Report published by the New Mexico Legislative Finance Committee has not been favorable for the exemptions. In fact, the report is very negative. I have posted some talking points on the Albuquerque MOAA website that you can use when discussing these two bills with your legislators. The Military/Veterans Legislative Council (MVLN) continues support this initiative and is in contact with appropriate legislators this session. The Albuquerque MOAA Chapter is a member of the MVLN with representatives on the executive and legislative council.

**House Bill 260** sponsored by several representatives proposes one day-use pass into state parks and recreation areas to veterans and gold star families. The bill has been recommended a “Do Pass” and is scheduled to be debated on the House Floor.


**House Bill 49** sponsored by sixteen Republican representatives proposes to exempt Social Security Income from New Mexico Personal Income Tax. The bill is awaiting hearing by the House Tax and Revenue Committee.

**House Bill 113** sponsored by Rep Harry Garcia, District 69, prohibits discrimination based on military or veteran status. The bill passed the House unanimously and is awaiting hearing by the appropriate Senate committee.

### **Stay in contact with your legislator before, during and after session**

There are a relatively large number of new legislators for the 2021 session. Ten new representatives and seven new senators amounting to a 25% turnover. The list of legislators has been published on the legislature website. Remember there are tutorials on the Legislature Website. On the Home page, open Quick Links and click Website Video Tutorials. Videos are available on Finding Legislation and Finding Your Legislators and MyRoundhouse. If you have a Zoom app on your computer, tablet or phone, you can “attend “committee meetings. At the Legislature website, [Home - New Mexico Legislature \(nmlegis.gov\)](http://nmlegis.gov) open the “What’s Happening” menu and open either the PDF version of the House or Senate Committee Schedules. The schedule will either list a link to join the Zoom meeting or provide instruction on how to join.
