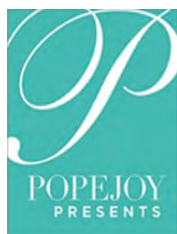

**The SBP DIC offset ended!!!**

Hurray! The final phase out is finished and the first whole payment of SBP will be Feb 1, 2023. This was a 19 year battle with Congress to get the law changed. MOAA was very instrumental in helping with this fight. What our spouses earned and sacrificed for will finally be restored. SBP is no longer reduced by DIC. Child option annuitants get SBP returned to them.

We changed a law through grassroots advocacy. This fight was won by many military widows who went in person to DC, made phone calls and numerous emails to their members of Congress and to members of Congress in states that they didn't even reside in.

I worked full time on passing this legislation a month after my Mike died. I poured my grief into the work. Grassroots advocacy works. Congratulations to all who worked on this.

## Commissioning of the USS Lenah Sutcliff Higbee DDG 123

The USS Lenah Sutcliff Higbee DDG 123, the Navy's newest Aegis Guided Missile Destroyer, will be commissioned on 13 May 2023 in Key West Florida.

This is the first time that a woman of the Naval Service will have a combatant vessel, the USS Higbee, named in her honor.

Lenah Sutcliff Higbee was born in Chatham, New Brunswick, Canada on 18 May 1874. She completed her nursing training at New York Post graduate Hospital in 1899 and received further training at Fordham Hospital.

On 1 October 1908 she became one of the first 20 nurses of the newly-formed Navy Nurse Corps, later known as The Sacred Twenty. Lenah Higbee's duty station was the US Naval Hospital, Washington, D.C. becoming Chief Nurse in April 1909.

Then, she became the first superintendent of the Navy Nurse Corps on January 20, 1911. During her service she was the first living woman to receive the NAVY CROSS for her distinguished service during World War I.

On November 30, 1922, she was honorably discharged at her own request. Mrs. Higbee died in Winter Park, Florida in 1941. She is buried in Arlington National Cemetery next to her husband LCOL John Henley Higbee, USMC.

To note that 15% of the crew is female to include the ship's Command Master Chief.

# Albuquerque Chapter MOAA Quarterly Social

## Sunday, March 19, 2023

**Our Chapter Quarterly Social Potluck gathering will be on Sunday, March 19, 2023 from 1200 to 1400 hours at the NM Veterans Memorial Park Visitor Center, conference room.**

Please bring a favorite *hor d'oeuvres*, *tapas*, salad, or light dessert to balance the afternoon presentations and discussion. The topics of the day will be the Chapter Charitable Giving opportunities for 2023 and visiting various vendor display tables.

We have invited Folds of Honor New Mexico, a 501(c)(3) organization that provides scholarship support to children and spouses of fallen or disabled veterans and first responders.

Higher Education scholarships are awarded to spouses and children currently attending or recently accepted into a 2-year or 4-year degree program at an institution or higher education or a vocational/certification program. Their Children's Fund scholarship seeks to provide support for dependents enrolled in grades K-12. COL (R) James Quick, USAF, will provide an overview of the organization and families served in New Mexico and across the U.S.

Our second presenter will be Shirley Johnson, Secretary and Board of Directors member. She will provide an overview of the Honor Flight of Northern New Mexico's (HFNNM) program for 2023 and going forward to 2024. HFNNM was established as a 501(c)(3) non-profit hub of the Honor Flight Network in 2013 with the goal of honoring as many New Mexico Veterans as possible.

Top priority is given to World War II and Korean War Veterans and Veterans of other conflicts who may be terminally ill, although Vietnam War Veterans have been added as seats are made available.

The trip to our nation's capital is free of charge to the veteran and includes airfare, lodging, meals and all transportation within the Washington, D.C., area. During the trip, veterans are able to visit the World War II Memorial as well as the Lincoln, Vietnam War and Korean War Memorials. (There currently are no longer any living veterans from World War I.) We will also view the Changing of the Guard at Arlington National Cemetery. The trip to Washington, DC takes 25 veterans every June to see the memorials built to honor their service.

Veterans are chosen for each trip on a first come first served basis. Priority is given to WWII veterans first. Next priority is given to Korean War Veterans and any veteran who is terminally ill is moved to the top of the list. Documentation from their physician is required. If there is a medical condition or disability, HFNNM needs to know what it is so they can take the necessary staff/family member to help us accommodate the veteran.



Vietnam Veterans are emerging on the selection list for the trips. Vietnam Veterans are chosen in the order their application was received and the number depends on how many terminally ill, WWII, and Korean Veterans are going. Currently, there are 100 Vietnam Veterans on the waiting list (2023-2027).

Albuquerque Chapter MOAA Vietnam Veteran era members who would like to get in the queue for an HFNNM trip to our nation's capital, do not put off applying. HFNNM travel applications are available at their website: [Applications - Honor Flight of Northern New Mexico \(honorflightnorthernnm.org\)](https://www.honorflightnorthernnm.org) . You will need to provide a copy of your DD-214 with the application and a release of medical records if there is a medical condition or disability for HFNNM to consider.

Additionally, we invited other central NM veteran 501(c)(3) organizations on our Charitable Giving list to attend and continue to communicate with Chapter members regarding their continuing support and services to active duty, NM National Guard, retirees, spouses, and families.


Additionally, for the first time, we will have vendor display tables available to all attendees showcasing helpful information and items from how to keep you and your home safe to information on the VA's Home Improvement & Structural Alterations (HISA) application process presented by a representative from Bath Fitter of Albuquerque.

*P.S: Because we do not have a Genie in a bottle or the assistance of elemental spirits (gnomes, satyrs, pans, dryads, elves, brownies, and goblins) to help set-up the meeting room at the NM Veterans Memorial Park Visitor Center for humans to display their intriguing rations on serving tables, provide dining tables with sanitary clothes, chairs to sit, and implements to dine and drink in a clean, bright and festive atmosphere.*

*We need a cadre of able body veterans to arrive at 10:30 hours to organize and construct the dining and social hall; and then clean, wipe, collect debris, and restore the room as if no one was ever there by 1500 hours.*

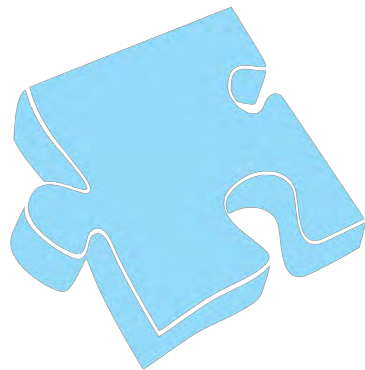
