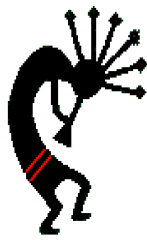

VA Hospital Mask Update sent from the Center for Development and Civic Engagement, New Mexico VA Health Care System:

“There has been a revision to the Mask policy and Covid guidelines here at the facility. Please see the message below from the Executive Leadership Team regarding these changes. If you have any questions please do not hesitate to contact our office at 505-256-2771 or abqvolser@va.gov. “

“Masking will no longer be required for inpatient units, including ICU, medical and surgical beds as well as inpatient SCI and mental health units. They are also not required for outpatient clinical settings, congregate settings, or laboratory areas.

Administrative areas and hallways also do not require masking. Masks will remain available throughout the facility and different stations and clinic areas. Anyone who feels more comfortable wearing a mask is encouraged to do so.”

Why your help is needed at the Veterans Memorial Park Visitor Center

The Veterans Memorial Park Visitor Center and Museum is staffed by the veterans' organizations in the greater Albuquerque area in order to make the Museum, Visitor Center, and conference room available for visitors, tourist, veterans' organizations, Sandia National Laboratory, and units at Kirtland AFB. Volunteer support to the Veterans Memorial Park Visitor Center and Museum is coordinated by the New Mexico Veterans Memorial Park and Museum Foundation and United Veterans Council of Greater Albuquerque.

The greater percentage of volunteers are from the non-profit veterans' organizations in the greater Albuquerque area. Volunteer support also comes from organizations that support military veterans and advocacy, such as the National Society of the Sons of the American Revolution, Daughters of the American Revolution, Honor Flight of Northern New Mexico, among others.

Use of the Veterans Memorial Park Visitor Center conference room, patio, amphitheater, parade field, and rose garden are available for rental use by military veteran organizations, community service and support groups, and individuals associated with these military and service organization (think, the Dukes of Albuquerque concert band).

The New Mexico Veterans Memorial Park and Museum Foundation and the City of Albuquerque have established a rental fee for use of the interior and open spaces at the New Mexico Veterans Memorial Park. Examples of the current rental fees for sites at the Memorial Park without security support are:

Meeting Room at the Visitor Center:

Fee for use of up to 4 hours = \$850; for events 5-8hrs = \$1200; or \$100 for each additional hour.

Visitor Center Patio can be included in Meeting Room as a package or rented separately: Fee for use of up to 4 hours = \$850; for events 5-8hrs = \$1200; or \$100 for each additional hour.

Amphitheater (including Parade Field): Fee for use of up to 4 hours = \$850; for events 5-8hrs = \$1200; or \$100 for each additional hour. There are ancillary charges for electric hook-up, use of tents or canopies (subject to City Fire Safety Ordinances), and opening restrooms for use.

Rose Garden, renter must provide own tables, chairs, and refuse-trash services: Fee for use up to 4 hours = \$600; for 5-8hrs = \$950; and \$50 for each additional hour.

Outside Grounds, can include Amphitheater, parade grounds, and vendor areas; renter must provide their own tents or canopies (subject to City Fire Safety Ordinances), tables, chairs, and refuse-trash services: Fee for use up to 4 hours = \$1200; for 5-8hrs = \$1800; and \$200 for each additional hour.

Boulevard of Flags Set Up (Park entrance and exit): Fee is \$100.

Hypothetical charges to Albuquerque Chapter MOAA for one year:

- ◆ Monthly Board of Directors Meeting using the Conference / Meeting Room at the Park Visitors Center (12 X \$200 = \$2,400)
- ◆ Annual Chapter Members Meeting (\$850 and \$100 for each additional hour over 4 hours; or \$1200 for 5-8hrs). The Visitor Center is open 9:00 AM to 3:00 PM. We commonly begin at 9:00 AM, lunch buffet from 11:00 to 12:30, Chapter meeting and reports until 1:30, and clean-up and disposal of trash until 4:00 PM. There is a charge to have a Memorial Park Foundation member present to monitor and to secure the building following the event. Charge is \$30/HR.
- ◆ Annual Memorial Service honoring members who passed away the prior year is held in the Amphitheater. Fee for 4 hours use = \$850.
- ◆ Quarterly Chapter Socials using the Conference / Meeting Room at the Park Visitors Center. (4 X \$300 = \$1,200)
- ◆ Special events, i.e., recognizing members 100th Birthday and recognizing and presenting member awards, using the Conference / Meeting Room at the Park Visitors Center. (2 X \$300 = \$600)
- ◆ Ski Club meetings and trip recruitment, using the Conference / Meeting Room at the Park Visitors Center. (6 X \$300 = \$1,800)
- ◆ Ski Club post season members meeting and social using the Conference / Meeting Room at the Park Visitors Center. (\$850 and \$100 for each additional hour over 4 hours; or \$1200 for 5-8hrs). Charge to have a Memorial Park Foundation member present in the facility after business hours and the Visitors Center is facility officially closed (3:00 PM on Saturday and Sunday) to monitor the event and to secure the building following the event. Charge is \$30 per hour .
- ◆ Each room or facility rental requires posting a \$300 damage and cleaning retainer.

As one can see, monthly program rental use of the Veterans Memorial Park Visitor Center conference room, patio, amphitheater, and parade field, hypothetically, can be as much as \$8,800 per year! These rental fees create a financial burden on organizational annual budgets when there is not a corporate sponsor with an open auditorium, gymnasium, or social hall to hold their events (VFW, American Legion posts and lodges, and churches). As a charitable non-profit organization having to pay such fees to conduct internal programs would severely curtail the funds that the Chapter could donate and deliver to support community veteran causes and needs.

Albuquerque Chapter MOAA has extensively used the New Mexico Veterans Memorial Park facilities to conduct Chapter meetings, socials, presentations, and memorials free of rental fees. Our MOAA Chapter is signed on to provide volunteer(s) to be present at the New Mexico Veterans Memorial Park Visitor Center and Museum the first Sunday of each month which means we are called upon 12 days per year to volunteer six hours of duty to support the Memorial Park.


Over the years our volunteers have included our officer, surviving spouse, and associate members being present in the Park's Visitor Center and Museum one Sunday each month. We currently are at a point when the longtime cadre of volunteers have diminished.

In the past we had timely and reliable support from our surviving spouse members. It is our practice to pair two surviving spouse volunteers at the Visitor Center and Museum for a three-hour Sunday shift. We need volunteers from our retired uniformed officers to provide a physical presence at the New Mexico Veterans Memorial Park and Museum. Volunteering twice a year for a three-hour watch is a small individual time donation to the Chapter that allows us to continue to use the New Mexico Veterans Memorial Park facilities rent free for Chapter organizational events. It additionally allows us to continue to provide funds to a variety of charitable veteran organizations and causes.

We continue to need your voluntary assistance and commitment to continue to support the Veterans Memorial Park and Museum and to better use our membership and charitable member donations for the local community of needy veterans.


VETERANS INTEGRATION CENTER UPDATE

As I work with our previous webmaster on this project, I'm looking for input from our chapter members.

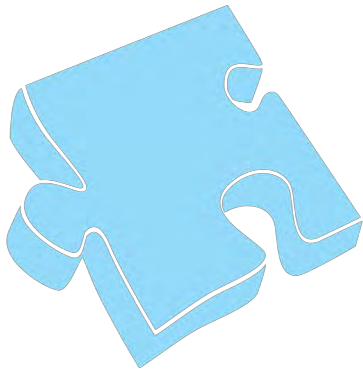
