SHUTTLE:

Complimentary town shuttle around Crested Butte and Mt. Crested Butte (ski area) — The Stop is 1/2 block from the Inn. The town shuttle runs at least every 15 minutes and travels 2 1/2 miles to Mt. Crested Butte, stopping at the ski area, returning to the Old Town Inn via a swing around the downtown area.

COST: \$870/person for coach transportation and 4 nights' lodging (double occupancy). **Those not using the BUS: \$500/person. Single w/ Bus: \$1370.** There may be an additional charge for more than two occupants.

***SKI LIFT COST:** EPIC passes are at <https://www.skicb.com/plan-your-trip/lift-access/passes.aspx> You will get a discount if ordered at least 9 days in advance. The price is the same that is offered for group tickets.
